**RE: Calleguas – Las Virgenes Interconnection Project**

This letter is to inform you that Las Virgenes Municipal Water District (LVMWD) will commence construction on the Las Virgenes – Calleguas Interconnection Project in January 2021, in the vicinity of your home or business.

This joint effort with Calleguas Municipal Water District (CMWD) improves the reliability and flexibility of our drinking water supply, as well as reinforces our ability to deliver water during droughts, natural disasters, and required system maintenance.

Construction will be performed on Lindero Canyon Road between Kanan Road and Thousand Oaks Boulevard. This project involves construction of a new pipeline and pump/pressure reducing station that interconnects our two drinking water systems. LVMWD will undertake construction of the southern pipeline segment from January to May 2021, with CMWD to follow with construction of the pump/pressure reducing station and the northern pipeline segment starting approximately in July 2021.

In order to mitigate impacts as much as possible, LVMWD is taking the following measures:

- **Specified work hours and truck route restrictions.** LVMWD will remove traffic control measures (signs, cones, barricades, etc.) at the end of each work day to avoid impacting Lindero Canyon Road outside of construction hours, and trucks are not permitted on residential streets during construction.
- **Pedestrian and bike travel.** LVMWD will maintain pedestrian and bike travel along Lindero Canyon Road during construction activities.
- **On-site construction manager.** A construction manager will be on site during all construction activities to ensure adherence to work hours and restrictions, and address any issues as they arise.
- **Environmental mitigation measures.** CMWD and LVMWD have been through an exhaustive environmental review of the project and will ensure all mitigation measures recommended in the Environmental Impact Report are responsibly executed, and that environmental impacts are minimized during construction.
- **Coordination with local permitting agencies.** LVMWD is working closely with the cities of Westlake Village and Thousand Oaks to coordinate and minimize further impacts on residents.

Continued maintenance and system upgrades are an integral part of what we do at LVMWD. This interconnection project is just one of many initiatives the District is conducting in order to guarantee a reliable water supply, build strong relationships with our neighbors, and ensure a sustainable future for our customers.
