## Las Virgenes Municipal Water District - Water Conservation Qualified Landscape Professionals

The individual professionals listed here can help homeowners conserve water applied to landscapes and keep everything looking nice. Many can work with the landscapers you already have to help them control water use.

The <u>California Landscape Contractors Association</u> (CLCA) certifies professionals in Water Management. These professionals have managed a landscape for one year at or below the landscape water budget, not exceed 100 percent of reference evapotranspiration (ET<sub>o</sub>) or other landscape water consumption requirements that are more demanding, such as 80 percent of ET<sub>o</sub> for new landscapes or to levels a local jurisdiction defines as "on budget." Expert level certification requires management of at least five properties. Find a CLCA certified landscape professional.

<u>Green Gardens Group (G3) EPA certified Watershed Wise Landscape</u> professionals have completed a comprehensive training program in sustainable landscaping techniques, current technologies and applicable ordinances and guidelines, including soil restoration, California-appropriate plant selection, native habitat creation, dry-weather runoff elimination, storm water pollution prevention, water harvesting and reuse, water budgeting for landscapes, and sustainable landscape stewardship practices. <u>Find a G3 certified landscape professional</u>.

<u>Irrigation Association</u> certifications (*IA*) that have earned the WaterSense label include the Certified Irrigation Designer (CID); Certified Irrigation Contractor (CIC); and Certified Landscape Irrigation Auditor (CLIA). The <u>EPA WaterSense</u> program partners with professionals who have been certified through a WaterSense labeled certification program and sign an agreement to practice efficient irrigation. <u>Find an IA certified landscape professional</u>.
